What Government Costs in North Carolina Cities and Counties

One of the most controversial issues in North Carolina politics is how best to fund needed government programs at the local level. Dozens of counties have asked for taxing authority in addition to the property tax and other traditional sources. At the state level, lawmakers have debated funding inequity in public schools and the impact of population growth on the ability of localities to deliver services. More recently, both the governor's office and legislators have considered reducing or eliminating state reimbursements for local taxes repealed during the 1980s, moves that cities and counties say could lead to additional tax increases or service reductions.

All of these debates would benefit from more and better information. Citizens need to know how much they are paying in local taxes and fees so they can decide whether additional sources of funding are needed.

Methodology

Using data on property taxes, sales taxes, and miscellaneous taxes and fees from the State Treasurer's Annual Financial Information Report, we calculated county and municipal tax and fee burdens, 1) as a percentage of income (for counties) and 2) per capita (for counties and municipalities). We then constructed a set of rankings to more clearly view the cost of local government.

Although this analysis is by no means definitive, it moves citizens one step closer to grappling with this complicated issue.

Findings

North Carolina collected nearly \$15 billion in state tax and fee revenues for fiscal year 1999-2000. This represented 7.2 percent of the personal income of the state's citizens. In addition, local governments collected an additional \$9 billion in property, sales, and other taxes and fees, representing another 4.3 percent of personal income. Combining the two yields an 11.5 percent state and local tax and fee burden. Federal collections raise the total tax burden on North Carolinians to approximately 33.4 percent of personal income, on average.

In 1999-2000 the median total property tax burden by county in North Carolina was 1.82 percent of income, or just over \$400 per person. County rates ranged from 4.48 percent in Dare County (\$1,101 per person) to 1.08 percent in Alexander County (\$242 per person).

The median total local burden by county (including property, sales, and other taxes and fees) was about \$878 per person in 2000, up nearly 2 percent in inflation-adjusted terms from \$852 in 1999. As a percentage of income, the median burden by county was 3.99 percent, a 1.11 percent decrease from 1999. Counties ranged from a high of \$2,738 (11.14 percent of income) in Dare County to a low of \$565 in the per-person measure, in Alexander County, and 2.5 percent of the percentage of income measure, in Polk County.

It is important to note that incomes vary among counties, and this can affect the rankings. Counties of similar size and similar total tax collections can vary in their burden because of differences in per-capita incomes. Differences among counties can also reflect the rate and extent of annexation, which places more taxpayers onto municipal tax rolls. Additionally, our analysis excluded intergovernmental revenues, municipal electric and gas charges, bond-sale proceeds, and several other forms of revenue.

Finally, there is a wealth of detail, by county and by municipality, in the appendices accompanying this report. Though some data were not available, overall this report presents a fairly comprehensive picture of the cost of local government in North Carolina.

INTRODUCTION

Local Fiscal Policy is Becoming a Statewide Issue

North Carolina city and county governments have with increasing frequency come to the General Assembly to obtain new ways to tax their citizens. Bills to impose an additional penny of local sales taxes, to authorize impact taxes and transfer fees on new homes or businesses, and to provide local-option gasoline taxes have all been filed or discussed in just the past year.

But to authorize new local taxes is to assume that current revenue sources are inadequate. Whether this proposition is true depends to a great degree on to what extent current local taxes are imposed, how their proceeds have changed over time, and the effectiveness of the services they fund. Although advocates for various sides of the local tax debate frequently ask similar questions, they rarely employ up-to-date and comparable data with which to evaluate the various claims being made in the legislative debate on the issue.

BY THE NUMBERS 2002 helps to answer some of these questions. To quantify the impact of taxes and fees at the county and municipal levels, we collected data from the N.C. Department of the State Treasurer for fiscal year 1999-2000, as well as 1998-99 and 1997-98 for comparison. Building on the Treasurer's methodology, this report categorizes revenue as from property taxes, sales taxes, or other sources. The sum of these revenues, less intergovernmental transfers (i.e. state or federal money given to local governments), is the total cost of local government.

Property Taxes

The tables in the back of this report present 1) per-capita property taxes, 2) per-capita sales taxes, and 3) per-capita total local revenue. To obtain the per-capita property tax, we divided the total amount of property tax collected by the jurisdiction's 2000 population. For counties, we then divided this per-capita amount by the county's per-capita personal income to determine the share of income that went toward county property taxes. Unfortunately, data on per-capita income became available more slowly than the other factors considered; as a result, fiscal 1999 income data were used. Because of this and other data construction issues, minor discrepancies may exist in the results presented.

Readers will immediately notice the relatively high per-capita property taxes in many resort communities in North Carolina. Given the nature of the data, this is not surprising. Second homes and resorts certainly do appear on local tax registers. However, as owners or renters only rarely live in these dwellings year-round, such localities typically have small permanent populations. High tax values divided by a small permanent population will produce a high per-capita tax burden. Therefore, these numbers are not necessarily comparable to other tax-burden statistics.

Sales Taxes

We used a similar approach to calculate per-capita local sales tax revenue for municipalities and counties, and, in addition, local sales tax revenue as a percentage of personal income for counties. As might be expected, given that the local sales tax rate was 2 percent throughout most of North Carolina at the time, there is much less variation in the results. Factors that may influence the amount of revenue collected would include per-capita income and local shopping patterns. Tourist areas and urban centers tend to have higher per-capita sales tax revenues, as people from surrounding areas come to visit and shop. Of course, this factor also influences property tax collections to the extent that it impacts the productivity and thus the value of commercial property in a jurisdiction.

Total Tax and Fee Burden

We measured total local government revenue using a methodology similar to previous years' reports. We report per-capita figures for both counties and towns, and for counties alone, total local government costs as a portion of per-capita income. This methodology excludes intergovernmental transfers, electric and gas charges, airport revenues, investment earnings, sales of materials, fixed assets, and real estate, proceeds from bonds, capital leases, and installment purchases, and certain "other" revenue sources that, we believe, would make fair, apples-to-apples comparisons difficult or even impossible.

This report uses the same approach to water and sewer revenues we adopted last year. Municipalities often provide service to other towns or residents of unincorporated areas. Because the pattern of such service provision is difficult to determine, water and sewer revenues have been excluded from the municipality and county-only data.

One change in this year's report is the exclusion of airport revenues. While a case can be made for their inclusion, as a practical matter not all major airports are controlled by the cities or counties they serve. We therefore have decided to remove these data from our measurements, and have adjusted the numbers for previous years accordingly to ensure that they remain comparable.

To measure the combined fiscal burden of local government, we combined all taxes, fees, and charges within a county (excluding revenues mentioned above but including water and sewer revenues), whether assessed by the county or any of the municipalities within the county. To measure the relative burden this imposed on residents of that county, we divided the total tax amount by the county's per capita personal income as of fiscal year 1999.

Lastly, we ranked counties and municipalities by their relative burdens. Municipalities were sorted by population and then ranked within four population ranges (under 1,000 population; 1,000-4,999; 5,000-24,999; and more than 25,000). All 100 counties were ranked relative to one another.

For comparison, we have included a full set of results for counties and rankings for municipalities for the 1998-1999 fiscal year. To make fair comparisons, these earlier year figures have been adjusted by changes in the Consumer Price Index (CPI). Readers wishing to obtain actual collections in 1998-1999 may multiply the listing by 0.968.

Level of Government Service Not Measured

Finally, while the data presented in this report show the cost of local government as represented by taxes and fees, we do not attempt to measure the quantity or quality of services provided in exchange for those dollars. Nor does this analysis measure the additional out-of-pocket costs to individuals for services that their local government may not provide. In unincorporated areas, for example, homeowners may have to contract privately for garbage pickup, while those living in a town or city may well receive this service, paid for through their municipal property and other taxes.

Importantly, this means that whether a jurisdiction is ranked high or low in cost of government is not the end of the debate over fiscal policy — it is merely the beginning. Citizens of North Carolina's cities and counties must decide whether the services they receive are worth the price they and their fellow residential and business taxpayers are paying in local taxes and fees.


