LEADING BY NOT DOING

Few counties and school districts receive donations, even from pro-tax residents

KEY FACTS: • Every county and school district in North Carolina will accept voluntary contributions.

• Few people donate to Wake County schools or county programs.

• Most donations are to specific schools and county programs, such as the K-9 unit or EMS.

• Contribution patterns reveal that most taxpayers prefer not to give more money to county government and the public school system.

o prudent family waits until after it pays for a vacation to see if there is enough money for the mortgage. Likewise, no *prudent* government waits until after it pays for parks or doles out money in corporate subsidies to see if there is enough money for education or sewers. New revenue should go to the item highest in priority after everything already in the budget. If that next item is another teacher or a 911 center, the implication is that everything already in the budget was more important than that teacher or the 911 system.

Every school district and every county government in the state will accept cash or in-kind donations from individuals, foundations, and companies. People can contribute to their school system in the same way they make other charitable contributions; *i.e.*, according to what they believe is the best use of their money. The John Locke Foundation has examined donation patterns in Wake County to see how much people took advantage of opportunities to donate. In particular, we asked whether some of those who are speaking the loudest about making public education a priority are making a similar commitment as part of their own budgets – whether they are walking the talk.

Other states have had little success with their voluntary contribution programs, sometimes called "Tax-Me-More" funds.¹ The Federal government has long accepted donations as well, again with limited success (billionaire Warren Buffett, for example, has said and demonstrated that he trusts the Gates Foundation will use his money better than the government will).² North Carolina's

state government does not accept donations. If a person does write a check to the state, it will count as tax revenue and will be refunded to the individual if it exceeds his tax liability. When I tried to make a donation, the Treasurer's Office, Controller's Office, and Department of Revenue said they had never had offers from individuals or companies to voluntarily contribute to the state's funding needs.³

On the other hand, local schools and county governments do take voluntary contributions. Wake County schools and county government, however, have received little in voluntary contributions for their budgets. The Wake County Public School System (WCPSS) has a \$1.1 billion operating budget and \$900 million voterapproved building program for the

2007-08 school year,⁴ but donations the system has tracked since May 2003 total less than \$2.4 million, just over 0.1 percent of one year's spending. The vast majority of those donations, 88 percent, have gone to individual schools, many for specific programs. These targeted gifts accounted for 77 percent of the donated funds.⁵

Donations to the county itself are an even smaller portion of total spending. Most voluntary contributions to the county target the K-9 unit of the sheriff's department or the emergency medical system (EMS). Not only do these areas directly affect people's lives, but EMS receives most of its voluntary contributions through selling subscriptions.⁶ The largest single contribution was actually a \$63,000 payment from grocery chain Harris Teeter in the wake of a 2002 Hepatitis scare (see Figure 1).⁷

Despite poll results in 2005 in which 49 percent of Wake County residents claimed they would be willing to pay more taxes for more teachers and smaller classes, roughly the same percentage (47 percent) said the schools received enough money and another 22 percent said schools receive "more than enough" from county commissioners.⁸ To judge by their willingness to contribute to the school system, however, even these poll numbers do not reflect people's true preferences.

Many people seem to have a disconnect between what they claim are their public priorities and what are their private resource allocations. The reality is that anyone can donate all the money they desire to county governments and school systems (see the lists provided by the appendices). Until they do, they have no right to demand that their neighbors, who may have different values and priorities, be compelled to have more taken.

Schools should seek contributions

Public school systems could take a page from universities and private schools with capital campaigns and annual giving campaigns to supplement public funding. They can do more to tap their alumni for donations.⁹ County gov-

ernment could take a look at the K9 unit, EMS, and children's health clinics to see what these departments do to encourage donations and other voluntary contributions, and whether any of their efforts can transfer to schools. In the end, if they want to receive the money their advocates say they need, county governments and public school systems will have to prove that they can use their money as effectively as private forprofit and non-profit organizations.
